Zane Akins of Zane Akins & Associates attended the beginning of the meeting to discuss strategic future planning for the Suri Network in connection with the Suri Network Breed Standard. After discussion with Board, Mr. Akins agreed to submit a proposal to the Board with costs for assisting the Suri Network with their strategic planning at the August Board meeting and Summer Symposium. Mr. Akins then left the call.

- **A. Minutes:** Mike Murphy moved to approve the Board of Trustee meeting minutes of May 9, 2007. Miriam Donaldson seconded the motion. Motion passed.
- **B.** Treasurer's Report: Toni Cotton reviewed the current financial reports and in comparison the prior year. Jim Barker moved to accept the Treasurer's report. Miriam Donaldson seconded the motion. Motion passed.
