

Synopsis of SN meeting at F2F: The group discussed options for future research projects and educational programs for the SN Membership. The items discussed were a full day suri fleece symposium to be held in November 2005, assistance with a scanning electron microscopy study being done at Ohio Weselyn University, the possibility of measuring fiber luster via the use of a "lustermeter," the gathering of research that has been done on fiber and the establishment of an e-library of fiber research that will be available through the SN website, and a new fiber research project which is described in detail below.

– Research Project for TSN

Goal: This study was designed to provide an in depth research project looking at suri fleece characteristics from 100 Suri alpacas using a combination of skin biopsy, micron testing via YM and Whittick and scanning electron microscopy. The project will be designed as a linear study over a two year time frame, from birth until two years of age. The skin biopsies and SEM studies will be performed as specified ages throughout the two year study. The fleece from these animals will also be evaluated for weight, density, staple length, lock structure, luster and handle. Our goal is to determine whether or not lock structure correlates with luster, density, handle, primary to secondary follicle ratio, SD, CV, staple length, micron and scale pattern.

Materials and Method:

1. Two animal study groups, final number in each group to be determined

- 2. Information on each animal:
 - a. Age
 - b. Color
 - c. ARI number

- d. Weight, Body Condition Score
- e. Sex
- f. Height to withers
- g. Photograph
- h. Study group location
- i. Phenotype diversity will include donors of various lock and luster
- j. Blanket from specified shearing intervals (to be specified in the final research proposal).
 - i. Fleece Weight-overall blanket will be taken
 - ii. Laser scan of sample
 - iii. SEM (Scanning Electron Microscopy) of fiber
 - iv. TEM scan of sample
 - v. OFDA 2000 analysis for fiber length and diameter over a 12 month period
 - vi. Luster Evaluation via refract meter of clean fleece
 - vii. Amino Acid Evaluation of fiber samples
 - viii. Tensile Strength. ...will need additional funding

k. Skin Biopsy from the collection sight to measure the ratio of primary to secondary hair follicles.

Suri Network Breed Standards Committee

AOBA Midwinter Conference -Atlanta, GA

Seven SN members participated in the first meeting of the SN Breed Standards committee held in conjunction with an all day gathering sponsored by SN at the midwinter AOBA Fiber to Fashion conference in Atlanta.

Participating members were: Kristina Flagel, Carol Karsten, Liza McArthur, Greg Mecklem, Susan Tellez, Dick Walker, and Janet Wilkins. Dick Walker, SN President is the Board of Trustees liaison to this newly formed committee.

There was a round table discussion regarding a variety of issues.

- Pros and cons of developing a breed standard.
- Difference between a Show
- Standard and a Breed Standard.
- How best to insure a broad based of input when establishing a breed standard.
- The importance of including commercially important fleece characteristics in a breed standard.
- Identifying areas where more investigation is needed in order to establish a preferred breed type base on objective data rather than an individual's aesthetic preference.
- Identifying key constituencies with a vested interest in this process to be certain they are represented.

It was felt that the process of developing a Suri Alpaca Breed Standard would proceed in several stages.

Phase One - Establish a pheno-

typic standard to define and delineate the preferred characteristics of the breed. Genotype could be addressed here as well, most appropriately regarding the issue of cross breeding with Huacaya alpacas.

<u>Phase Two</u> – Develop a grading system that incorporates objective measurable criteria important to advancing the quality of desirable heritable qualitative and quantitative traits.

The committee thought that a discussion regarding Phase One could begin utilizing two existing documents: AOBA Show Rules and the Screening Criteria used initially to screen all suris imported to the USA. Many of the issues that will need to be considered in developing a breed standard will be included to some degree in those sources. What is not necessarily included, however, is a designation of relative values given to important suri phenotypic traits. For example: is lock type and definition more or less important than luster; is density more or less important than fineness, etc.? Similar consideration needs to be given to conformation traits as well. These and other issues will be very important to consider as our industry contemplates a standard. The heritability of any given trait will deserve consideration.

Several areas were identified that urgently require further investigation:

- How does lock structure correlate with luster, density, handle, primary to secondary follicular ratio, SD, CV, staple length, micron, scale pattern?
- How does lock structure affect the processing of suri fiber?

• With regards to suri fiber what are the most important determinants of commercial value that should be

incorporated in a breed standard? Suggested actions for the board to consider implementing:

1) Officially notify the AOBA board and the ARI board that SN plans to move forward in developing a prototype Suri Alpaca Breed Standard.

2) Establish a timetable for implementation.

3) The following sequence of events are felt to be necessary for completion of this process:

• identify participants and mode of communication, i.e. conference calls, newsletter, e-mail, face to face, etc

• disseminate information for review by participants

- draft initial Breed Standard document; a face to face meeting is suggested
- review period for comments, additions, changes to draft
- finalize the prototype Suri Breed Standard, another face to face is recommended

• approval by Board and membership,

• schedule the first Suri Breed Standards Review Conference for 1-2 years post implementation. A built in review process will facilitate evolution of the standard as research indicates the need for adjustments. Procedures for this periodic review should be established as part of the initial Breed Standards document.

At every step it will be vital to keep our membership fully informed on this process. The education committee may be of assistance for this task.

4) Employ a consultant to assist in implementing this process.

SURI NETWORK ANNUAL MEETING NOTICE

The Suri Network Annual Meeting will be held on <u>Thursday, June 2, 2005</u>, from 7:30 am to 8:00 am in Room 300A, at the South Towne Exposition Center in Sandy, Utah. This meeting will be held to thank the outgoing Board of Trustees (Stacy Wilkins & Cindy Fronk) and to announce the result of the elections.

Suri Fleece Symposium <u>Fleece Collection Protocol</u>

- Suri Fleeces needed: The Suri Network is requesting a minimum of 100 Suri fleeces to be donated for the Suri Network fleece bank for both the November, 2005 Symposium and for other Fleece Judge's Training Clinics. These fleeces will eventually be retained in a central location for use around the country.
- 2. The donated fleeces should be of show quality with the following specifications
 - a. Any age between 6 months to 5th birthday and older if show quality
 - b. Any color
 - c. Any weight as long as it is the entire blanket
 - d. Yocum-McColl or OFDA fiber testing results included with the fiber
 - e. 2005 and/or 2004 clip. Fleeces with dampness, mustiness, live insects will need to be discarded. (The fleeces will be skirted later for vegetable matter, etc).
- 3. Packaging:
 - a. Place each fleece in a clear plastic bag

- b. Include the following information:
 - i. Alpaca's DOB
 - ii. Date of shearing
 - iii. ARI registered color
 - iv. Copy of Yocum-McColl or OFDA micron testing results
 - v. Farm name and contact information. (This information will not be shared with the judges, but is for purposes of advertising your farm as a donor and for sending an acknowledgement regarding your donation.
- 4. <u>Shipping</u>: Send the donated fleece(s) to:

Deadline for receiving fleeces: August 15th, 2005. This will give time to prepare the fleeces for the November 11th Symposium.
